General Rules

1. The academic session spans from July to June every year.
2. A student may be expelled from the college due to participation in ragging activities, irregular attendance, misbehavior, disobedience or on using unfair means in examination.
3. Any willful damage done to any property of the college will be made good by the concerned parents / guardian.
4. No parent shall offer any gift or gratification to any member of the staff. Parties to any member of the staff or other functions arranged in their honour require prior permission of the management.
5. College authorities are in on way responsible for the loss of any item brought by the student in the campus.
6. Failure to pass the examination may result in expulsion of the student from the college. However, the management can exercise discretionary power to re-admit the unsuccessful to the same class in the next academic session as a special case.
7. Parents / Guardian are not allowed to see their ward during the class hour without prior permission of the Director / Principal.
8. Discipline and decent behavior are given the importance. Every students is expected to obey the faculty and follow the rules and regulations set by the college.
9. Use of profane words, insulting language or immoral behavior will be considered a serious offence that can amount to the student's expulsion from the college.
10. Unauthorized absence from the college shall be considered as a serious misconduct and strong disciplinary action shall be taken against the defaulting students.



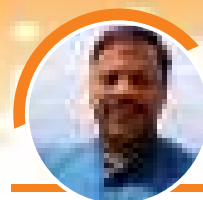

Ragging is banned in SC Guria Law College

Ragging of any nature is strictly banned at SC Guria Law College. Any student found involved in any case of ragging will be suspended with immediate effect without any immediate probe. The student shall be given an opportunity to present his case at a later stage. This policy of the institute is based on the Supreme Court orders given to ban ragging in the institutions.

As per SC ruling based on R.K. Raghvan Committee, "Ragging in essence is human rights abuse".

Anti Ragging Policy

Raging in the college campus is banned and any one indulging in ragging is likely to be punished as per the direction of Hon'ble Supreme Court of India, The Punishment may include fine, suspension from the classes for a limited period or both and even expulsion from the University.

The following will be termed as act of Ragging:

- Teasing, treating or handling with rudeness any other student;
- Indulging in rowdy or in disciplined activities;
- Causing or generating a sense of shame or embarrassment to a fresher or a junior student.
- All concerned may note the following:
- Ragging is unsocial. Illegal and punishable.
- Ragging in any form at any place in the campus or outside is strictly prohibited.
- Any student found indulging in the act of ragging will be liable for strict disciplinary action as mentioned above.

An anti-Ragging cell has been established by the college authorities for curbing the menace of Ragging. All the cases of Ragging will be referred to the anti-Ragging cell which will recommend suitable punishment for the guilty as per law.

Punishment

The following disciplinary measure may be adopted by the college authority in dealing with misconduct on the part of the student.
